1. A player seeking a transfer from one club to another shall present the transfer form for signature to the Rúnaí of the Club he wishes to leave. The player seeking transfer must sign and complete the form in Irish.
2. Forms provided by the County Committee for this purpose must be used by all players and clubs.
3. All transfer requests **signed** and **unsigned** must be with an Rúnaí Chontae by **5.00 p.m.** on **15<sup>th</sup> January**.
4. The County Competitions Control Committee shall process and decide on all applications for Transfers and Exemptions, signed and unsigned, within the county as per **Rule 6.5 T.O. 2016**.
5. It is the **responsibility** of the **Player or Club** seeking the transfer to ensure that the above is complied with.
6. Club Secretaries must sign (*in Irish*).
7. An appeal against the decision of the County Competitions Control Committee on application for transfer may be made in writing by the aggrieved party to the County Hearings Committee within 3 working days (72 hours) of receipt of the notification of the decision as per **Rule 6.5 (f) T.O. 2016**.

***All relevant questions must be answered in full otherwise the transfer, may, at the discretion of the County Competitions Control Committee, be ruled out of order.***
